Hello, summer days are here again and so is a new edition of our accreditation newsletter. I hope the warmer weather finds all of you safe and healthy.

A quick recap of accreditation activities includes the end of a month's long collaboration process in February that we worked on with the AAP Journal's group who oversee our journal-based CME activities. A huge thanks goes out to Joe Puskarz, Heidi Willis and Josh Sinason who spent countless hours this winter providing information for their CME files. We also started strategizing on the changes we will need to implement by year end in regards to the release of the new Standards of Commercial Support from our accreditor, The Accreditation Council for Continuing Education (ACCME). Another huge thank you goes out to my colleagues Dave Andrews and Stephanie Tate who, to this day, continue working with us on implementing changes to our internal disclosure system to ensure we will be in compliance before the new rules take effect in 2022.

March then brought about the submission of our annual report data to our accrediting agency and is one of the biggest annual tasks we conduct. For more information on this submission and a summary of the 2020 activity data we reported, please see page 2

April brought about our participation in the ACCME annual meeting and included my participation in a multimonth workgroup on Applying the Standards for Integrity & Independence in Academic CPD: Successful Frontline Management where several volunteers from organizations across the country practiced, and troubleshooted, applying the new standards into our existing CME programs. The meeting also included a compelling discussion with leaders across the continuum of health professional education to share multifaceted perspectives on

our learners and systems of today and the future. The keynote also stressed that the switch to online formats, brought upon us ten fold by the pandemic, is essentially here to stay so we should all get comfortable with the virtual world. Additionally, and reiterated throughout the program, was the importance of advancing the ideals of Diversity, Equity, and Inclusion in continuing education for health professionals to facilitate meaningful change. All of us, as part of the CME education cycle, has the opportunity and responsibility to be part of the solution by helping to navigate a path from empathy to understanding to action with our educational activities.

May was busy preparing for the annual meeting of our oversight committee, The Committee on Continuing Medical Education (COCME), that took place in June. At the meeting we all said farewell to Dr Foulds, whose term as chair ended in 2021 (read more about it on page 9) and welcomed new committee chair Dr Rani Gereige. Additionally the ACCME released resources to help clinicians confidently and safely administer the COVID-19 vaccines, as well as information to support CME providers in developing and delivering education about the COVID-19 vaccines, which can be found at https://www.accme.org/ covid-19-learn-vaccinate-clinician-and-educatorresources. We also signed up to be part of an ACCME trial group to start reviewing and testing new changes to PARS (the system we use to report our annual activity data each year) that our accreditor plans to release later this summer.

Finally, the accreditation team put on a really great CME 101 PDW this July for all new staff at the Academy (you can read more about it on page 8) and the COCME released new educational materials that you, as well as your planners and faculty, will find helpful so please visit the COCME website (cocme.courses.aap.org) to access.

2021 Annual Reporting for the AAP CME/CPD Program

In order to maintain its accreditation status, AAP must annually report every individual activity that it conducts and submit specific activity information to the Accreditation Council for Continuing Medical Education (ACCME). This information includes, but not limited to:

- —final income figures (ads, exhibits, reg, financial support)
- final MD and non-MD participants

—evaluation information

—final expenses

As we continue to fulfill our obligation each year to the ACCME by submitting this required information, it's with many thanks to those involved in this endeavor that helped make it happen for 2020. We especially want to thank our Direct Providers within the AAP Dept. of Education, Direct Providers outside the AAP Dept. of Education (non-DOE department/divisions), and Joint Providers (Chapters/Districts/ABP) not only for the activities they managed during a very difficult year, but for the dedication and hard work in providing the Accreditation Team with the requested information to report. We're happy to share the following information that was submitted for our 2020 activities:

Number of CME Activities	380 CME activities total 290 directly provided activities (140 of which also awarded MOC Part 2 Points) 90 jointly provided activities (15 of which also awarded MOC Part 2 Points)
Number of CME Credits Awarded	3,736.75 CME credits total 2,850.50 directly provided credits 886.25 jointly provided credits
Number of Leamers educated	 410,722 learners total 228,814 MDs and 142,813 non-MDs in directly provided activities 36,379 MDs and 2,716 non-MDs in jointly provided activities

Many thanks to AAP Staff and Dr Haftel for embracing the new AAP COI process that launched last January. Everyone has done a great job adopting the new process.

Keep in mind if in doubt...contact the Accreditation Team, we are here to help. Reminders:

- All that affect content must disclose for the activity.
- Send out disclosure request when you start planning your activity, work with your Planstone superuser.
- Review financial relationships received to ensure applicable notes have been added that provide details about the relationship (this will
 assist with the resolution/mitigation process).
- Follow up with those that have not completed their disclosure
- Allow ample time (minimum of 5 days) for Dr Haftel's review/mitigation of relationships (contact Virginia Roldan, she will work directly with Dr Haftel).
- All disclosures must be collected/reviewed/mitigated and shared with participants prior to the start of the activity...no exceptions.

CME Toolbox

Giving you the tools you need to build a compliant CME Activity

ACCME UPDATES-EFFECTIVE JAN 1, 2022



Our accreditor has released newstandards that will need to be in effect NO LATER than January 1, 2022. When the ACCME updates their standards we must follow suit so that we are in compliance with their policies. We recently touched on these changes inbrief meetings with Activity Managers—thank you to those that were able to attend and provide feedback. We have sent our questions for clarification to the ACCME. Here is a recap/review of the information shared in the meeting:

PLANSTONE/DISCLOSURE UPDATES:

__Disclosure: The ACCME extended the disclosure period from 12 to 24 months and will now be asking for ALL relationships, not just those relevant to the activity they are disclosing for.

- We will no longer ask the off-label disclosure question but instead include a statement on the AAP Disclosure grid used for all activities stating that off-label discussion may occur during this activity. Grid will also contain a statement indicating all disclosed relationships have been successfully mitigated.
- —**Planstone:** Due in large part to the updated ACCME standards for disclosing, we will be moving to an annual disclosure process that aligns with our leadership disclosure process. We have combined the leadership and CME questions into one disclosure form that will be completed annually.
- With this change will come some process changes within Planstone as both CME and Leadership will be in the same container. We have gathered your feed back from the meetings and will do our best to incorporate your ideas into our process
- To maintain consistency with the margining Leadership and CME disclosures, spouse/family members disclosure will continue to be collected
- The biggest difference is that these disclosures will only need to go out ONCE a year—if you know who is going to be participating in CME then request for disclosure should go out at the same time as leadership disclosures. If you find someone later in the year who will be participating, you should check to see if they already disclosed in Planstone and if not simply send them are quest to disclose.

OTHER ACCME CHANGES:

- —Ancillary Marketing and nonaccredited activities: The ACCME has defined how much time (30 minute interval) must separate accredited activities and marketing or non accredited activities if they are held in the same room.
- Activities that are part of the event but not designated for CME credits must be clearly labeled and communicated to learners
- If the content of the non-CME session would not cause any planners/speakers to have relevant financial relationships (such as a business meeting, legislative update, awards ceremony), then the 30 minute rule does not apply.
- <u>Language changes</u>: commercial interest is now referred to as ineligible companies, resolution is now mitigate, CME is now continuing accredited education
 - While we will continue using the term CME, you will start so see various formal accreditation documents use the new terminology—Planstone system will also use the updated language.

—Attendees must consent in advance to sharing contact information with exhibitors and commercial supporters

- This can be an opt in or opt-out option but learners MUST give consent to have their information shared so please keep that in mind as you start to plan for 2022 activities
- We will be working to see if this can be incorporated into the registration process through meeting services/ NetForum
- —**No selling or promoting of materials** during a CME activity (presenters must stop short of selling the product by saying it is available at the AAP resource center)
 - CME must be free of marketing or sales of products or services. Faculty must not actively promote or sell products or services that serve their professional or financial interests during the activity.


We are diligently working on updates to Planstone and our forms that we plan to start rolling out by the end of the month—we will also create new educational documents/resources and will be reaching out to super users and activity managers to train/update everyone on the new processes starting in September.

If additional activity specific information is included, such as credit amounts, faculty and/or objectives, full credit statements must be included.
I can use logos to a cknowledge commercial support.	NO-Logos of commercial interest CANNOT be used to acknowledge support for an activity. Only company/organization name can be used to acknowledge this type of support.
Verification requirements don't always have to be shared with learners	Verification requirements (all required CME information) MUST always be shared with learners prior to the start of the every CME activity.
Evaluation questions do not need to be asked for every activity.	AAP required evaluation questions must be asked of all activity participants regardless if they are claiming credit or not.
MOC 2 assessment tool does not need to provide feedback to the learner.	ALL MOC 2 assessment tools must include individualized feedback to learners on their performance
MOC 2 assessment tool does not need to be approved by the accreditation team.	ALL MOC 2 assessment tools must be reviewed and approved by Accreditation before they can be used in your activity.
I do not need a Letter of Agreement (LOA) when accepting commercial support for my activity.	Ensure you complete and submit an LOA for each commercial supporter (monetary or in-kind). LOAs must be submitted, reviewed, approved and signed by the AAP Accreditation prior to activity launch.
Exhibitors are NOT allowed at activities.	Exhibitors are allowed. Exhibitor guidelines must be submitted and approved. Exhibit space must be kept separate from the areas (live or online space) in which you offer education. You cannot have exhibitors in the same rooms as educational sessions.
I do not need to review presentation slides	Yes, as the activity manager you are responsible for reviewing to address all copyright/HIPPA/commercial interest/brand names and bias. Ensuring presentations include a disclosure slide. Presentation should then be sent to Accreditation team for approval at least 48 hrs prior to launch.
I only need to complete Annual Reporting the year my activity launches.	Activity manager is responsible for providing Annual Reporting data for the entire life of the activity. If an activity spans multiple calendar years, you will submit your annual report data each year it was available for credit.
Accreditation team tracks my activity participants and data.	No, activity managers will need to track participant numbers, financials, evaluation data, and MOC 2 results/feedback for the entire time the activity is available for CME/MOC credit
Enduring materials can be extended without approval from Accreditation Team	NO. Enduring materials are approved for 3 years. Activity managers then have the option to extend it for 1 additional year after a review has been completed and approval secured from Accreditation. Contact Accreditation Team at least 6 months before activity is set to expire.



COPYRIGHT

Copyright is one of the intellectual properties. It protects the authors of "original works of authorship." A book, a piece of music, website, software and almost any other expression may be copyrighted.





Page 6

A painting/portrait of you is considered a derivate work and the painter holds the rights to the painting/portrait. You must get permission from the painter to display or reproduce the work.

Owner of a work is the person who actually creates the work, the person who transforms an idea into a fixed, quantifiable expression.

If you create a work on behalf of your employer, your employer is the author of the work you prepared for the scope of your employment.

Make sure your volunteer leaders understand the copyright laws —if they didn't create the original work, they don't own it. If they are the owner of the work, you will need to get a copyright transfer/assignment. When a person joins a committee, have them sign a volunteer copyright assignment form.

If you hire a vendor to produce a work for you (it's called work made for hire), you must get a copyright assignment. Must be a written agreement signed by both parties that explicitly states the work being commissioned will be a work made for hire.

Copyright protection automatically applies to all covered works. No registration is necessary.

Copyright Duration: Within the US, copyright works extends for the lifetime of the creator plus 70 years. If the work is made -for-hire, the term is 95 years from the date of first publication or 120 years from the date of creation.

Transferring Rights and Licensing: The copyright holder retains all rights not specifically granted in the license.

Policy Statement created by a person on a committee: If you receive a release from a group that created the policy statement, it will still be in place even when the person no longer works on the committee.



Webinar – you need a license to distribute/copy the work.

Journal masthead – if language is not listed about reprint in the issue, you must get the authors permission.

Fair Use — Fair use permits the use of a limited excerpt of copyrighted materials without a license for criticism, comment, parody, news reporting, teaching, scholarship, or research.

SENSEMAKING

Sensemaking is the process of collecting info from all sources and creating a new map to help make better decisions. The idea of "sensemaking" was developed by Carl Wake in order to help the CDC make sense of information when new diseases came out.



Sensemaking is proven to make organizations more effective but is sometimes not as high on the priority list as most leaders tend to focus on putting out current fires instead of long termplanning. Some key Components in sensemaking include

- Examining Assumptions
- Collecting Small Data
- Understanding the needs and perspectives of all stakeholders
- Testing

Sensemaking helps you to take a step back and look at the bigger picture, it is a long term strategic planning effort. The goal behind sensemaking isn't to create a flawless picture of what is happening within your organization, but instead, it is about learning.

Some ways you can bake sensemaking into your organizations culture are:


- 1. Teach
 - Complex process and will need some focus on interviewing and speaking with a new audience
- 2. Map
 - How doyou sit together and live with uncertainty—it wont be perfect
- Experimenting
 - Try out on a small scale and see how it works and then strategize on what needs to be revised and refined?
- 4. Embed in your leadership and HR practices
 - Need people at every level across team to be involved and invested in sense making
 - It should also be rewarded, specifically helpful if it is in annual performance review
 - Knowing not to do something is equally as important as knowing TO DO something

Some Important "Didyou?" questions to ask yourself when using sensemaking

- 1. Get data from multiple sources?
- 2. Pursue different opinions
- 3. Test your assumptions
- 4. Seek out multiple perspectives
- 5. Iterate and act
- 6. Talk to people outside your team, unit and organization.




Accreditation Unit Virtual Retreat
